## DOME: the initial requirements

#### European industrial technology roadmap for the next generation cloud-edge offering

MAY 2021







Common European marketplace for cloud and edge services ...

... to serve as a key enabler crucial to deliver on the EU Data Strategy's ambition to

- facilitate adoption across Europe of cloud and edge service offerings,
- that comply with EU regulation, European standards,
- as well as user expectations in terms of data sovereignty, security, portability, or energy efficiency.

This open marketplace concept would also strongly contribute to

- breaking down silos between national / sectorial markets across the EU, and
- accelerate integration across the continent.

The aim would be to serve the entire EU market, from <mark>public administrations to</mark> industry, including SMEs.



Common European marketplace for cloud and edge services

Such a marketplace would serve as a one-stop shop for cloud-edge applications from all providers that abide by European regulation.

It would level the playing field and lower barriers to entry for smaller service providers.

Under its most simple format, a European cloud marketplace would aggregate compliant services into an openly accessible, certified catalogue, with a search function allowing users to find solutions that match their criteria.

Beyond this information-sharing and match-making capability, the marketplace could also provide brokering features to facilitate transactions between providers and customers.



The marketplace could be built to enable multi-tenancy: the service catalogue and technical foundations would be the same across Europe, but allow different entities to operate the marketplace for different user bases.

For example, Member States wishing to have their own marketplace for their national public sector consumption of cloud and services according to a specific framework contract could operate an instance of the marketplace and thereby still access the same service catalogue.

A network of connected instances could thereby feed into a meta service catalogue.



# Common European marketplace for cloud and edge services

The marketplace foundations would be developed as open source, with open APIs, and integrate third party transparency for services such as verifying provider authorizations and certifications.

Given the marketplace would, at least in its first years, be built and operate as a publicgood, public-private collaboration is required to cover the build up and initial rollout costs.

Finally, early onboarding of a significant set of providers and users will also be key to accelerate the achievement of a critical mass of traffic to further its adoption, and leverage the lessons learned from leading global marketplaces to enlarge its user base.








# Scope of functionalities in version 1.0 (Catalog)



# eIDAS2 Regulation (11 April 2024) on the European Digital Identity Framework

Section 1, Article 5f-2:

Where private relying parties that provide services are required by Union or national law to use strong user authentication for online identification or where strong user authentication for online identification, including in the areas of transport, energy, banking, financial services, social security, health, drinking water, postal services, digital infrastructure, education or telecommunications, those private relying parties shall, no later than 36 months from the date of entry into force of the implementing acts referred to in Article 5a(23) and Article 5c(6), accept European Digital Identity Wallets that are provided in accordance with this Regulation.

# LEAR Credential: electronic Powers of Representation

#### **LEAR Credential**

#### Mandator

The Legal Representative who delegates some powers in the Mandatee for some specific purposes.

#### Mandatee

The employee who receives some powers for some specific purposes. Called the LEAR.

#### **Powers of Representation**

The list of specific powers which the Mandator delegates to the Mandatee.

#### Signer

Either the Mandator or a trusted third party attesting the Mandate.

#### Advanced/qualified signature/seal Using an eIDAS certificate of the Signer, binding the Mandate with the legal identity of the Signer


Allows an employee to act on behalf of an organisation for a specific set of activities.

A machine-readable document (JSON) where:


- The legal representative of the company delegates into the employee a set of limited powers to perform specific activities with thirdparties.
- The Verifiable Credential is signed by the Legal Representative using an eIDAS certificate issued by one of the qualified trust service providers in the EU.




# Verifiable Credentials as electronic Powers of Representation



















# Future: the Certification agency issues a Verifiable Credential




The flow is very simple:

- The CSP receives the certification in its enterprise wallet.
- The CSP sends the certification to DOME onboarding.
- DOME verifies automatically the authenticity of certification and that it is one of the required certifications.
- Identities of certifications agencies are in the Trust Framework



# Today: services to "convert" PDF to Verifiable Credential



There is an intermediate trusted service:

- Verifies the content of credential (typically natural language).
- If it is not digitally signed, checks with the certification agency (may be manual or automatic).
- If it is signed, checks signature, and that signer is authorised.
- Generates a VC and returns it to CSP.

The Trusted Service can be provided by DOME and by other market operators.
